Camp Jefferson's driveway is approx. 1 mile up Weldon Road on the left. Drive straight ahead to the large log building and park. During the summer months the monthly meetings are transformed into picnics which are held at various local parks. A picnic schedule with directions can be found on the club's web site.

By bringing any guests, I expressly agree that OSF, Inc., its officers, trustees, event chairpersons, and other members assisting in arranging the functions are held harmless and indemnified by me and my guests for any injuries, damages, or losses. I further acknowledge that I have advised all my guests that they are deemed to hold harmless and indemnify OSF, Inc., its officers, trustees, event chairpersons, and other members assisting in arranging the functions by their participation in these activities.

I understand that Outdoor Single Friends, Inc. was established to provide the opportunity for single (divorced, widowed, separated or never married) people to interact in a social, educational and positive atmosphere.
